Translated Documents Reminder

It’s always the best-case scenario to have a translated document that the LEP can read for themselves. In the event the LEP is not literate, then the lawyer/judge/appropriate person would need to review the document with them and the interpreter would interpret. It is not appropriate for the interpreter to review a document with the LEP as that moves them out of their interpreter role.
